WHISTLEBLOWING DISCLOSURES RECEIVED ABOUT WARRINGTON COUNCIL

Thank you for your email received on 2 October 2023 to the National Audit Office. In your email, you asked us to confirm how many whistleblowing disclosures we have received about Warrington Borough Council in the past four months. Your request has been handled under the terms of the Freedom of Information Act 2000 (FOIA). Your original request to us has been reproduced under **Annex A** for your reference.

I can confirm after reviewing our records, that we do not hold any information within the scope of your request. We have not received any Whistleblowing disclosures within the past four months regarding Warrington Borough Council.

It may help if I briefly explain that the NAO and the Comptroller and Auditor General (C&AG), who is the head of the NAO, are both independent of government. Our function is to audit and express an opinion on the financial statements of government departments and other government bodies, and to carry out examinations into the economy, efficiency and effectiveness with which government departments and other public sector bodies utilise their resources. The results of this work are normally reported to Parliament. While we can consider whether public money is spent cost-effectively, the legislation defining our role does not permit us to question government policy objectives nor consider the merits of how public money is spent.

The NAO's role and remit does not extend to auditing, and reviewing whistleblowing disclosures made which relate to individual local bodies such as Warrington Council as they are separately and locally accountable. For concerns raised regarding local councils, the relevant external auditor appointed to the council is the appropriate person to consider these.

Annex B sets out the steps you may wish to take if you are not satisfied with the way we have handled your request for information under the FOIA. I am sorry we haven't been able to help answer your request, but I hope the information provided above is useful in understanding the role and remit of the National Audit Office.
