Annex A

Request for information:

(Your request is in italics and our response below)

"Can you tell me if anyone who applied to the Windrush Compensation scheme has the surname Hughes and was born in British Guiana, now Guyana, or the Dutch Caribbean? Can you tell me if any of the individuals from whom Windrush scheme applicants derived their claim to British citizenship had the surname Hughes and were born in British Guiana, now Guyana, or the Dutch Caribbean? If you have any question, or there is some other archive or office I should contact, please let me know in your reply."

NAO response

We have searched our records and can confirm that we do not any information in scope of your request.

The NAO published a report 'Investigation into the Windrush Compensation Scheme' on 21 May 2021. This covered the Home Office's (the Department's) establishment and administration of the scheme and the progress it had made in implementing changes from December 2020. It sets out:

- the history and development of the compensation scheme;
- the Department's engagement activity;
- the number of compensation claims and payments; and
- the Department's administration of the scheme.

The data we received from the Home Office for this investigation was fully anonymous and contained no details allowing us to identify an individual. The name, date of birth, birth country and nationality of applicants was removed before the data was shared with us. Therefore, we do not hold any information that could answer your request.

If you have not already done so, you may wish to contact the Home Office who are the owners of this data with questions about the scheme. However, it may help to explain that information about identifiable individual applicants would be personal data about third parties. The Home Office is unlikely to disclose this information under FOIA as the exemption in Section 40(2) of FOIA (personal information) is likely to apply.

Annex B
