NAO STAFF TURNOVER

Thank you for your request of 26 March 2024 asking for all information relating to staff turnover at the National Audit Office. Your request was considered in accordance with the terms of the Freedom of Information Act 2000 (FOIA). Having reviewed our records, I can confirm that we hold some of the information that falls within the scope of your request.

With regards to question 1, we do not record any data in relation to staff turnover split according to gender, however you may find some helpful information on staff breakdown by gender, in our <u>NAO Diversity and</u> Inclusion Annual Report 2022-23.

I have attached an excel spreadsheet along with this response which breaks down staff turnover from the financial year 2017-18 to 2023-24 by audit grade to answer part of question 2. The figures represent both the turnover in number and in percentage.

Your specific request has been reproduced under **Annex A** for your reference. **Annex B** sets out the steps you may wish to take if you are not satisfied with the way we have handled your request for information under the FOIA.
